Declaration about Risks

The current Declaration of risks ("Declaration") has been made for the purposes of warning the User about the risks of accomplishment of the deals through the usage of the website invest-vitrina.com ("Website") and about delimitation of responsibility between the User and LLC "Corporation "Razvitie" ("Company"), Primary State Registration Number (OFPH): 1183123018880, Taxpayer Identification Number (MHH): 3123439322, situated on the address: Russian Federation, city of Belgorod, 85 Pobedy str., building 17.

Having studied the current Declaration, the User takes all possible risks connected to the accomplishing of the operations and deals by means of the Usage of the Website.

The Declaration is presented for all interested subjects declared their intention to use the Website.

By this, the Company informs that

- it does not accomplish the checking and the analysis of the information allocated on the Website, does not guarantee its objectivity, authenticity, completeness, adequacy and actuality.
- it does not check business reputation or paying capacity of the people registered on the Website or the fulfilment of their obligations concerning earlier concluded deals by means of the Website;
- all actions and operations accomplished by the User, accomplished himself or herself independently, on the basis of his or her knowledge and beliefs at his or her fear and risk. If any circumstances of accomplishing of the deal or the conditions of its conclusion are not clear for the User and evoke doubts in the rightfulness of the deal, he or she may address for the qualified help (legal, financial, technical etc.)

or by another mean provide full understanding of the sense of the deal before its conclusion and show the necessary caution during the conclusion.  responsible for all actions (and also their consequences), accomplished on
